Peoples Ltd. Declares Third Quarter Dividend

Wyalusing, PA – Peoples Ltd. (OTC: PPLL) Anthony J. Gabello, President and Chief Executive Officer of Peoples Ltd., has announced that the Board of Directors has declared a third quarter cash dividend in the amount of \$0.58 per share payable on September 30, 2021. The cash dividend represents a 10.7% increase over the cash dividend paid in the third quarter 2020 of \$0.52 as adjusted for the 2020 year-end 5% stock dividend.

The declaration of dividend, made at the regular meeting of the Board of Directors on August 25, 2021, is payable to shareholders of record September 13, 2021.
