Peoples LTD Declares First Quarter Dividend

Wyalusing, PA – Peoples LTD (OTC: PPLL) Anthony J. Gabello, President and Chief Executive Officer of Peoples LTD, has announced that the Board of Directors has declared a first quarter cash dividend in the amount of \$0.53 per share payable on March 29, 2019. The cash dividend represents a 13.50% increase over the cash dividend paid in the first quarter 2018 of \$0.47 as adjusted for the 2018 year-end 5% stock dividend.

The declaration of dividend, made at the regular meeting of the Board of Directors on February 27, 2019, is payable to shareholders of record March 15, 2019.
